#### 1. INTRODUCTION

The Company's existing general mandates to issue shares and to repurchase shares were approved by the Company's then shareholders on 5th June, 2007 at the 2007 annual general meeting of the Company. Unless otherwise renewed, the existing general mandates to issue shares and to repurchase shares will lapse at the conclusion of the 2008 Annual General Meeting.

In order to ensure flexibility when it is desirable to allot additional shares or to repurchase shares, the directors of the Company (**the "Directors"**) will seek the approval of shareholders to grant new general mandates to issue shares and to repurchase shares at the 2008 Annual General Meeting.

Ms. Ng is responsible for the Group's sales and marketing and overall management. She is graduate of 廣州業餘大學 (Guangzhou Part-time University, the PRC) and holds a certificate in Arts. Ms. Ng has over 12 years' experience in real agency business. Except for being director in the Company, Ms. Ng has not held directorship in other listed company during the past three years. Ms. Ng's remuneration as director of the Company is HK\$1,300,000 per annum under her service agreement with the Company and subject to discretionary management bonus payment to be determined by the board of Directors (the "Board") based on the annual audited results of the Company in accordance with the terms of her service agreement. Ms. Ng's remuneration, which is commensurate with her duties and responsibilities held, is approved by the Board with reference to the prevailing market situation for similar appointment. As director of the Company, Ms. Ng is subject to retirement by rotation and re-election pursuant to the Articles of Association of the Company.

Ms. Fu Man ("Ms. Fu"), aged 47, is the co-founder of the Group and has been appointed as executive director of the Company under a service agreement commencing on 1st April, 2004 with an initial term of 3 years which continues thereafter until terminated by either party giving to the other party not less than three months' prior written notice.

Ms. Fu is responsible for the Group's sales and marketing and overall management. Ms. Fu attended 廣州大學科技幹部學院 (Technology College, Guangzhou University, the PRC) and holds a certificate in industrial foreign trade. Ms. Fu has over 12 years' experience in real agency business. Except for being director in the Company, Ms. Fu has not held directorship in other listed company during the past three years. Moreover, Ms. Fu is director of certain subsidiaries in the Group. Other than these positions, Ms. Fu has not held any other position with any member of the Group.

Ms. Fu is sister of Mr. Fu Wai Chung, chairman and substantial shareholder of the Company and is sister-in-law of Ms. Ng. Except as aforesaid, Ms. Fu does not have other relationships with any directors, senior management or other substantial or controlling shareholder of the Company for the purpose of the Listing Rules. As at the Latest Practicable Date, Ms. Fu does not have interest in shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Ms. Fu's remuneration as director of the Company is HK\$1,300,000 per annum under her service agreement with the Company and subject to discretionary management bonus payment to be determined by the Board based on the annual audited results of the Company in accordance with the terms of her service agreement. Ms. Fu's remuneration, which is commensurate with her duties and responsibilities held, is approved by the Board with reference to the prevailing market situation for similar appointment. As director of the Company, Ms. Fu is subject to retirement by rotation and re-election pursuant to the Articles of Association of the Company.

Mrs. Wong Law Kwai Wah, Karen ("Mrs. Wong"), aged 59, has been appointed as independent non-executive director ("INED") on 30th June, 2005 under an appointment letter for a specific term which may be extended for such period as the Company and Mrs. Wong may agree in writing and the period has been extended to 31st December, 2008.

Mrs. Wong holds a Bachelor of Arts degree from the University of Hong Kong and has over 31 years working experience in the real estate field. Mrs. Wong is a fellow member of the Chartered Institute of Housing Asian Pacific Branch and a fellow of the Hong Kong Institute of Housing. She is a licensed real estate agent and is currently the president of the Society of Hong Kong Real Estate Agents Ltd. Prior to the current appointment, Mrs. Wong was the General Manager of KCRC's Property and Commercial Services department and has retired since January 2008. Mrs. Wong does not hold any directorship in listed public companies in the past three years. Mrs. Wong does not hold any position with the Company and its subsidiaries. #### 6. PROCEDURES FOR DEMANDING A POLL

Pursuant to Article no. 66 of the Company's articles of association ("Articles of Association"), a resolution put to the vote of a general meeting shall be decided on a show of hands unless voting by way of a poll is required by the rules of the Designated Stock Exchange (as defined in the Articles of Association) or (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) a poll is demanded:

- (a) by the chairman of such meeting; or
- (b) by at least three members present in person or in the case of a member being a corporation by its duly authorised representative or by proxy for the time being entitled to vote at the meeting; or
- (c) by a member or members present in person or in the case of a member being a corporation by its duly authorised representative or by proxy and representing not less than one-tenth of the total voting rights of all members having the right to vote at the meeting; or
- (d) by a member or members present in person or in the case of a member being a corporation by its duly authorised representative or by proxy and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all shares conferring that right; or

(e) if required by the rules of the Designated Stock Exchange, by any director or directors who, individually or collectively, hold proxies in respect of shares representing five per cent. (5%) or more of the total voting rights at such meeting.

#### 7. ADDITIONAL INFORMATION ABOUT AUDITORS

It is noted that Zhong Yi (Hong Kong) C.P.A. Company Limited ("Zhong Yi") will not offer themselves for re-appointment as joint auditors of the Company at the 2008 Annual General Meeting because Zhong Yi will focus their business on the overseas markets. Zhong Yi confirmed that there were no matters in relation to their withdrawal of re-appointment that they considered should be brought to the attention of the shareholders of the Company. The Directors are not aware of any other circumstances that ought to be brought to the notice of the shareholders. Deloitte Touche Tohmatsu will still offer themselves to be re-appointed as the auditors of the Company at the 2008 Annual General Meeting.

#### 8. RECOMMENDATION

The Directors believe that the granting of the Issue Mandate and the Repurchase Mandate are in the best interests of the Company and its shareholders as a whole. Moreover, the necessary information regarding the re-election of the retiring directors at the 2008 Annual General Meeting is already set out herein for consideration. Accordingly, the Directors recommend that all shareholders should vote in favour of the related resolutions to be proposed at the 2008 Annual General Meeting.

This appendix serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to shareholders of the Company for their consideration as to whether to vote for or against the ordinary resolution to be proposed at the 2008 Annual General Meeting for granting the Repurchase Mandate.

This explanatory statement contains all the information required pursuant to rule 10.06 of the Listing Rules which is set out as follows:-

#### **SHARE CAPITAL**

As at the Latest Practicable Date, the Company had in issue an aggregate of 246,800,000 shares of HK\$0.01 each which are fully paid.

Subject to the passing of the ordinary resolution no. 6 as set out in the notice of 2008 Annual General Meeting and in accordance with the terms therein, the Company would be allowed under the Repurchase Mandate to repurchase fully paid shares up to the aggregate nominal amount of a maximum of 24,680,000 shares on the basis that no further shares will be issued or repurchased prior to the 2008 Annual General Meeting.

#### REASONS FOR SHARE REPURCHASE

Although the Directors have no present intention of repurchasing any securities of the Company, they believe that the flexibility afforded by the Repurchase Mandate would be beneficial to the Company and its shareholders. Trading conditions on the Stock Exchange have sometimes been volatile. At any time in the future when securities trading at a discount to their underlying value, the ability of the Company to repurchase securities will be beneficial to those shareholders who retain their investment in the Company since their interests in the assets of the Company would increase in proportion to the number of securities repurchased by the Company and thereby resulting in an increase in net asset value per share and/or earnings per share of the Company. Such repurchases will only be made when the Directors believe that the repurchases will benefit the Company and its shareholders as a whole.

#### **FUNDING OF REPURCHASES**

In repurchasing securities, the Company may only apply funds legally available for such purpose in accordance with the memorandum and articles of association of the Company and the applicable laws and regulations of the Cayman Islands. Securities may only be repurchased out of the profits of the Company or out of the proceeds of a fresh issue of shares made for the purpose of repurchase. The premium, if any, payable on repurchases must have been provided for out of the profits of the Company or out of the Company's share premium account before or at the time the securities are repurchased. The Company may not purchase securities on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

#### POSSIBLE MATERIAL ADVERSE IMPACT

- 4. To appoint auditors and to authorise the board of directors to fix their remuneration.
- 5. To consider as special business and, if thought fit, pass with or without amendments, the following resolution as an ordinary resolution:

#### "THAT

- (a) subject to paragraph (c) of this resolution, the exercise by the directors of the Company ("Directors") during the Relevant Period (as defined below) of all the powers of the Company to allot, issue and otherwise deal with additional shares ("Shares") in the capital of the Company or securities convertible into Shares, or options, warrants or similar rights to subscribe for any Shares, and to make, grant, sign or execute offers, agreements or options, deeds and other documents which would or might require the exercise of such powers, subject to and in accordance with all applicable laws, be and it is hereby generally and unconditionally approved;

- (b) the aggregate nominal amount of Shares and securities convertible into Shares which may be purchased by the Company pursuant to the approval in paragraph (a) of this resolution during the Relevant Period shall not exceed 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of this resolution, and the approval pursuant to paragraph (a) of this resolution be limited accordingly;

"THAT subject to the passing of the resolutions numbered 5 and 6 as set out in the notice (the "Notice") convening this meeting, the general mandate granted to the Directors to exercise the powers of the Company to allot, issue and otherwise deal with shares ("Shares") in the capital of the Company pursuant to the resolution numbered 5 as set out in the Notice be and the same is hereby extended (as regards the amount of share capital thereby limited) by the addition to the aggregate nominal amount of share capital of the Company which may be allotted or agreed conditionally or unconditionally to be allotted by the Directors pursuant to such general mandate of an amount representing the aggregate nominal amount of the share capital of the Company purchased by the Company under the authority granted pursuant to the resolution numbered 6 as set out in the Notice provided that such amount shall not exceed 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of this resolution."
