1. INTRODUCTION

The Company's existing general mandates to issue shares and to repurchase shares were approved by the Company's then shareholders on 26 June, 2019 at the 2019 annual general meeting of the Company. Unless otherwise renewed, the existing general mandates to issue shares and to repurchase shares will lapse at the conclusion of the 2020 Annual General Meeting.

In order to ensure flexibility when it is desirable to allot additional shares or to repurchase shares, the directors of the Company will seek the approval of Shareholders to grant new general mandates to issue shares and to repurchase shares at the 2020 Annual General Meeting.

The purpose of this circular is to, inter alia, provide you with information on (i) the proposed renewal of the general mandates to issue shares and to repurchase shares; and (ii) the retiring directors to be re-elected, for consideration on the related resolutions to be put forward at the 2020 Annual General Meeting.

2. THE ISSUE MANDATE

Two ordinary resolutions, as set out in the notice of the 2020 Annual General Meeting, will be proposed for the following purposes:

Ordinary resolution no. 5 — to grant to the Directors a general mandate to issue new shares up to a maximum of 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution; and

Ordinary resolution no. 7 — to increase the aggregate nominal amount of share capital of the Company which the Directors may issue under the general mandate if given in the ordinary resolution no. 5 by the aggregate nominal amount of share capital of the Company repurchased under the general mandate if given in the ordinary resolution no. 6.

The Company had in issue an aggregate of 674,149,989 shares of HK\$0.01 each as at the Latest Practicable Date. Subject to the passing of the aforesaid ordinary resolution no. 5 and in accordance with the terms therein, the Company would be allowed to issue additional shares up to the aggregate nominal amount of a maximum of 134,829,997 shares on the basis that no further shares will be issued or repurchased prior to the 2020 Annual General Meeting.

3. THE REPURCHASE MANDATE

The ordinary resolution no. 6 as set out in the notice of the 2020 Annual General Meeting, will be proposed to grant to the Directors a general mandate to exercise the powers of the Company to repurchase the Company's fully paid up shares representing up to a maximum of 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution.

The Listing Rules contain provisions to regulate the repurchase by companies with primary listings on the Stock Exchange of their own securities on the Stock Exchange.

In accordance with the Listing Rules, the appendix to this circular serves as the explanatory statement, to provide you with the requisite information reasonably necessary to enable you to make an informed decision on whether to vote for or against the ordinary resolution for granting of the Repurchase Mandate.

4. INFORMATION OF THE RETIRING DIRECTORS TO BE RE-ELECTED AT THE 2020 ANNUAL GENERAL MEETING

For your further information, we set out below the relevant details of the retiring directors proposed to be re-elected at the 2020 Annual General Meeting:

Mr. Fu Wai Chung ("**Mr. Fu**"), aged 70, the co-founder and chairman of the Group, has been appointed as executive director of the Company under a service agreement commencing on 1st April, 2004 with an initial term of three years which continues thereafter until terminated by either party giving to the other party not less than three months' prior written notice.

Mr. Fu is responsible for the strategic planning and overall management of the Group. He is a graduate of $\overline{\pm} \overline{\alpha} \pm \overline{\beta} \mathbb{R}$ (Wahnan Industrial College, the PRC) and holds a certificate in mechanical engineering. Mr. Fu has over 30 years of experience in real estate agency business management and administration in the PRC.

Save as disclosed above, Mr. Fu did not hold any directorship in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas. Mr. Fu is the director of certain subsidiaries in the Group. Mr. Fu is the spouse of Ms. Ng Wan, an executive director of the Company and Mr. Fu is the brother of Ms. Fu Man, an executive director of the Company and he is interested in 252,927,133 shares (representing 37.52% of the issued share capital of the Company) within the meaning of the SFO. Save as disclosed above, Mr. Fu does not have other relationships with any directors, senior management or other substantial or controlling shareholder of the Company within the meaning of Part XV of the SFO as at the Latest Practicable Date.

Mr. Fu's remuneration as director of the Company is HK\$2,400,000 per annum under his service agreement with the Company and subject to discretionary management bonus payment to be determined by the Board based on the annual audited results of the Company in accordance with the terms of his service agreement. Mr. Fu's remuneration, which commensurates with his duties and responsibilities held, is approved by the Board with reference to the prevailing market situation for similar appointment. As director of the Company, Mr. Fu is subject to retirement by rotation and re-election pursuant to the articles of association of the Company.

Mr. Mo Tianquan ("**Mr. Mo**") aged 55, has been a non-executive director of the Company since 1 April, 2015. He founded SouFun Holdings Limited (NYSE: SFUN) which now known as Fang Holdings Limited ("Fang") in 1999 and currently serves as the Executive Chairman of its board of directors. Mr. Mo is also the founder of China Index Holdings Limited (NASDAQ: CIH) and currently serves as the Chairman of the Board of Directors. Fang, a substantial shareholder of the Company, holds 111,885,625 shares of the Company. Mr. Mo is deemed to be interested in the shares Fang held. Save as disclosed above, he does not have any interest in the shares of the Company within the meaning of Part XV of the SFO.

Prior to founding Fang, Mr. Mo served as the General Manager for Asia at Teleres, a venture of Dow Jones & Co. and AEGON US that provided on-line commercial real estate information services (1994-1996) and the Executive Vice President at Asia Development and Finance Corporation (1996-1998).

Mr. Mo holds a Bachelor's degree in Engineering from South China University of Technology, a Master of Science degree in Business Administration from Tsinghua University and a Master degree in Economics from Indiana University.

Pursuant to the appointment letter, the term of appointment of Mr. Mo is 3 years commencing from 1 April, 2015 and thereafter may be extended for such period as the Company and Mr. Mo agree in writing. His appointment has been extend to 31 March, 2021.

Mr. Mo is subject to retirement by rotation and re-election at annual general meetings in accordance with the Articles of Association of the Company. No remuneration has been given or will be given to Mr. Mo.

Save as disclosed above, Mr. Mo has not held any directorships in any public listed companies in the past three years and is not connected with any directors, senior management or substantial or controlling shareholders of the Company. Mr. Mo does not hold any other position with the Company or any of its subsidiaries.

Mr. Lam King Pui ("**Mr. Lam**"), aged 54, has been appointed as independent nonexecutive director ("INED") on 30 May, 2004. He is currently appointed for a period up to 31 December, 2020 under a letter of appointment which may be extended for such period as the Company and Mr. Lam may agree in writing. He is the chairman of audit committee, remuneration committee and nomination committee of the Company.

Mr. Lam is a chief accountant of a Hong Kong company and company secretary of several Hong Kong companies. He holds a Bachelor of Arts degree in accountancy from the Hong Kong Polytechnic University and has over 30 years of experience in accounting. Mr. Lam is a fellow member of the Association of Chartered Certified Accountants, a Certified Public Accountant, an associate member of the Hong Kong Institute of Certified Public Accountants, the Institute of Chartered Secretaries and Administrators and the Hong Kong Institute of Company Secretaries. Mr. Lam did not hold any directorship in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas. Mr. Lam does not hold any directors, senior management, substantial or controlling shareholders of the Company for the purpose of the Listing Rules. As at the Latest Practicable Date, Mr. Lam does not have any interests in shares of the Company within the meaning of Part XV of the SFO.

Mr. Lam's remuneration is fixed at HK\$228,000 per annum under his letter of appointment with the Company, which commensurates with his duties and responsibilities as INED and the prevailing market situation. As director of the Company, Mr. Lam is subject to retirement by rotation and re-election pursuant to the Articles of Association of the Company.

The Board would consider to enhance its diversity with different expertise when appointing or re-electing an INED. Mr. Lam has met the independence guidelines set out in rule 3.13 of the Listing Rules and he has also given an annual confirmation of his independence to the Company this year. Mr. Lam has served in this capacity for more than ten years. Notwithstanding his long-term service, given his extensive experience in accounting, the Nomination Committee and the Board are of the opinion that he continues to bring independent and objective perspectives to the Company's affairs. The Board considers Mr. Lam is independent and can bring further contributions to the Board and its diversity. The Board and the Nomination Committee also believe that Mr. Lam should be elected because he continues to bring relevant financial and accounting experience and knowledge to the Board.

Save as disclosed above, the Board is not aware of any other matters or information that need to be brought to the attention of shareholders of the Company or to be disclosed pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules in relation to the proposed re-election of the aforesaid retiring directors.

5. **RESPONSIBILITY STATEMENT**

This circular, for which the directors of the Company collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

This appendix I serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to Shareholders of the Company for their consideration as to whether to vote for or against the ordinary resolution to be proposed at the 2020 Annual General Meeting for granting the Repurchase Mandate.

This explanatory statement contains all the information required pursuant to Rule 10.06 of the Listing Rules which is set out as follows:

SHARE CAPITAL

As at the Latest Practicable Date, the Company had in issue an aggregate of 674,149,989 shares of HK\$0.01 each which are fully paid.

Subject to the passing of the ordinary resolution no. 6 as set out in the notice of 2020 Annual General Meeting and in accordance with the terms therein, the Company would be allowed under the Repurchase Mandate to repurchase fully paid shares up to the aggregate nominal amount of a maximum of 67,414,998 shares on the basis that no further shares will be issued or repurchased prior to the 2020 Annual General Meeting.

REASONS FOR SHARE REPURCHASE

Although the Directors have no present intention of repurchasing any securities of the Company, they believe that the flexibility offered by the Repurchase Mandate would be beneficial to the Company and its Shareholders. Trading conditions on the Stock Exchange have sometimes been volatile. At any time in the future when securities trading at a discount to their underlying value, the ability of the Company to repurchase securities will be beneficial to those Shareholders who retain their investment in the Company since their interests in the assets of the Company would increase in proportion to the number of securities repurchased by the Company and thereby resulting in an increase in net asset value per share and/or earnings per share of the Company. Such repurchases will only be made when the Directors believe that the repurchases will benefit the Company and its Shareholders as a whole.
